Mbibana	<p>Starting from the South Western corner beacon the farm Pietersburg 671, proceed generally in an Easterly direction along the provincial boundary and traversing the farms Pietersburg 671, Darling 672, Hopefield 675, Gemoed 676, Tuinplaats 678, Gegund 679, Roodevlakte 632, Kalkpan 683, Zoedfontein 630. Continue along the provincial in a southerly direction along the farms Vlakplaats 689, Driefontein 693, Spitspunt 688 and leeuwkuil 686. Proceed along the northern, western and southern boundaries of the farm Bloedfontein 153 and then along the eastern and southern boundaries of the farm Rhenosterkop 157 to its South Western corner beacon. Then proceed South along the eastern boundaries of the farms Koraanbult 161, Leeuwfontein 188, Zandspruit 189 and Kameelpoort 202. Then proceed from the southern beacon of Kameelpoort 202 along its western boundary to the provincial boundary. Then proceed north along the provincial boundary traversing the farms Kameelpoort 202, Kloppersdam 187 and Bezuidenhoutkraal 166. Continue westwards and then eastwards along the provincial boundary traversing the farms Roodekoppies 167, Wynruit 168, Droogegrond 169, Witlaagte 173, Bultfontein 174, Rietfontein 31, Kumnandi 67, Pankoppen 36, Klippan 29 to the South Western corner beacon of the farm Valkfontein 143. Then proceed North along the provincial boundary to the starting point of the description</p>
