MAGISTRATES' COURTS ACT 1944 (ACT NO. 32 OF 1944): CREATION OF MAGISTERIAL DISTRICTS AND ESTABLISHMENT OF DISTRICT COURTS IN RESPECT OF THE LIMPOPO PROVINCE


I, Tshililo Michael Masutha, Minister of Justice and Correctional Services, acting under section 2(1)(a) and (f) of the Magistrates' Courts Act, 1944 (Act No. 32 of 1944), read with Item 16(6) of Schedule 6 to the Constitution of the Republic of South Africa, 1996, hereby with effect from 1 August 2015 in respect of the Limpopo Province and from 1 August 2015—

- (a) create magisterial districts listed under Column "A" of the attached Schedule and declare that such magisterial districts be called by the names referred to in the said Column; and
- (b) establish, in respect of the magisterial districts listed under Column "A", courts as indicated under Column "B" within the municipal areas listed under Column "C" of the Schedule, for the purposes of—
 - (i) the trial of persons accused of committing any offences which shall have jurisdiction contemplated in sections 89 and 92 of the Magistrates' Court Act, 1944; and
 - (ii) adjudicating civil disputes contemplated in section 29(1) of the Magistrates' Court Act, 1944.

Any criminal or civil proceedings which on the date this Notice takes effect has already been placed on the court roll for trial or hearing in a court whose area of jurisdiction has been altered by this Notice and which has commenced, shall be dealt with and be finalised by the court where the matter is enrolled as if this Notice has not been published.

The maps and descriptions of areas of jurisdiction of the courts established under Column "B" of the Schedule as indicated above, including such detached courts as may be established under the section 2 of the Magistrates' Court Act, 1944, will be published in the *Gazette* before 1 August 2015.
