

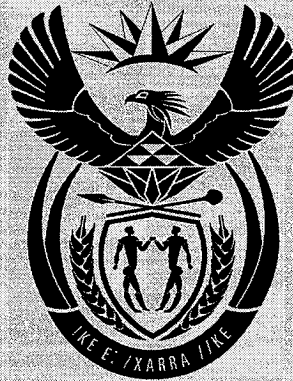

**MAGISTRATES' COURTS ACT, 1944 AS AMENDED (ACT NO. 32 OF 1944):
WITHDRAWAL OF NOTICES CREATING DISTRICTS AND ESTABLISHING COURTS
FOR THE LIMPOPO AND MPUMALANGA PROVINCES**

I, Tshililo Michael Masutha, Minister of Justice and Correctional Services, acting under section 2(l) of the Magistrates' Courts Act, 1944 (Act No. 32 of 1944), hereby,

- (a) withdraw Government Notice No. 268 published in the *Gazette* No. 38625 of 30 March 2015 which relates to the withdrawal of notices creating magisterial districts and courts in the Limpopo and Mpumalanga provinces; and
- (b) withdraw Government Notice No. 266 published in the *Gazette* No. 38623 dated 30 March 2015 which relates to the creation of magisterial districts and establishing courts for such districts in the Mpumalanga Province; and
- (c) withdraw Government Notice No. 267 published in the *Gazette* No. 38624 of 30 March 2015 which relates to the creation of magisterial districts and establishing courts for such districts in the Limpopo Province.

This Notice is deemed to have come into effect on 1 December 2015.
