

ESTABLISHMENT OF SMALL CLAIMS COURTS FOR THE AREAS OF PARYS AND VREDEFORT AND WITHDRAWAL OF GOVERNMENT NOTICE NO. 1068 OF 2 JUNE 1989

I, John Harold Jeffery, Deputy Minister of Justice and Constitutional Development, acting under the power delegated to me by the Minister of Justice and Correctional Services, under section 2 of the Small Claims Courts Act, 1984 (Act No. 61 of 1984), hereby -

- (a) (i) establish a Small Claims Court for the adjudication of claims for the area of Parys, consisting of the district of Parys;
 - (ii) determine Parys to be the seat of the said Court; and
 - (iii) determine Parys to be the place in that area for the holding of sessions of the said Court.
- (b) (i) establish a Small Claims Court for the adjudication of claims for the area of Vredefort, consisting of the district of Vredefort;
 - (ii) determine Vredefort to be the seat of the said Court; and
 - (iii) determine Vredefort to be the place in that area for the holding of sessions of the said Court.
- (c) withdraw Government Notice No. 1068 of 2 June 1989.

Despite the withdrawal of Government Notice No. 1068 of 2 June 1989, any claim emanating from the district of Vredefort which has already been instituted in the Small Claims Court of Parys prior to the publication of this Government Notice, shall be continued and concluded in the Small Claims Court of Parys as if this Government Notice has not been published.
