**MAGISTRATES' COURTS ACT, 1944****CREATION OF MAGISTERIAL DISTRICTS AND ESTABLISHMENT OF DISTRICT COURTS FOR GAUTENG AND NORTH WEST PROVINCES**

I Jeffrey Thamsanqa Radebe, Minister of Justice and Constitutional Development, acting under section 2(1) of the Magistrates' Courts Act, 1944 (Act No. 32 of 1944) (Magistrates' Court Act) read with Item 16(6) of Schedule 6 to the Constitution of the Republic of South Africa, 1996, hereby, with effect from 1 August 2014: -

- (a) Create, in respect of municipalities listed under Column "A" for the Gauteng and North West Provinces, magisterial districts listed under Column "B" of Schedules 1 and 2 and declare that they be called by the names referred to in Column "B" of the said Schedules; and
- (b) establish, in respect of the magisterial districts mentioned under Column "B" of Schedules 1 and 2, courts as indicated in Column "C" of the said Schedules for the purpose of -
  - (i) the trial of persons accused of committing any offences which shall have jurisdiction contemplated in section 89 and 92 of the Magistrates' Court Act; and
  - (ii) adjudicating civil disputes contemplated in section 29 (1) of the Magistrates' Courts Act.

Maps and descriptions of areas of jurisdiction of the courts established under Column "C" of Schedule 1 and 2 as indicated above including of detached courts as may be established under the aforesaid section of the Magistrates' Courts Act will be published in the Gazette on 28 March 2014 or soon thereafter.
