DEPARTMENT OF JUSTICE AND CONSTITUTIONAL DEVELOPMENT**No. R. 34****22 January 2015****PROMOTION OF EQUALITY AND PREVENTION OF UNFAIR DISCRIMINATION ACT, 2000 (ACT NO. 4 OF 2000): DESIGNATION OF MAGISTRATES' COURTS AS EQUALITY COURTS: AMENDMENT OF GOVERNMENT NOTICE NO. R. 859 OF 28 AUGUST 2009**

Under section 16(1)(c)(v) of the Promotion of Equality and Prevention of Unfair Discrimination Act, 2000 (Act No. 4 of 2000), I, Tshililo Michael Masutha, Minister of Justice and Correctional Services, hereby, with effect from 1 December 2014, vary Government Notice No. R. 859 of 28 August 2009, in so far as it is applicable to the Gauteng Province and the North West Province by —

- (a) designating all Magistrates' Courts mentioned in Column A of the Schedule as equality courts, in terms of section 16(1)(c)(i) of the said Act;
- (b) defining, in Column B of the Schedule, the area of jurisdiction of each equality court mentioned in Column A of the Schedule, in terms of section 16(1)(c)(ii) of the said Act; and
- (c) appointing the places mentioned in Column C of the Schedule as places of sittings of the equality courts mentioned in Column A, in terms of section 16(1)(c)(iv) of the said Act.

Despite the variation of Government Notice No. R. 859 of 28 August 2009, any proceedings pending before an equality court which are not finalised by 1 December 2014, must be finalised by that court as if the Government Notice had not been amended.
